The regular meeting of the Retirement Board of the Policemen's Annuity and Benefit Fund was held January 30, 2018, at 9:55 A.M. at the office of the Fund, 221 N. LaSalle Street, Room 1626, Chicago, Illinois for the consideration of applications and bills, and for other such matters that came before the Board. Portions of this meeting were transcribed by Esquire Communications, Ltd.
