Kevin Leonard of NEPC reviewed discussed current market conditions and performance of the Fund's portfolio.

Portfolio Rebalancing

Kevin Leonard of NEPC reviewed the current asset allocation of Fund's portfolio and recommended no change at this time. In addition, Mr. Leonard advised that NEPC recommends the Fund keep 3-4 months of cash on hand given market conditions.

Trustee Bennett entered the meeting during Mr. Leonard's summarization.

HEARINGS

All of the disability hearings scheduled for this date have been postponed. The hearings will be rescheduled after the COVID-19 Stay-At-Home order has been lifted and the Fund can provide a safe environment for everybody.

Erin Keane, the Executive Director reviewed with the Board members the actions taken to have staff successfully continuing their tasks and responsibilities and completing Fund business during the COVID-19 shut down.
