Directions -Summarized From RULES OF ELECTION (PETITION)

One (1) member is to be elected from among active members of the CPD of the rank of Lieutenant or rank superior to Lieutenant. The petition for each such candidate must be signed by twenty-five (25) persons duly qualified to vote for the Policemen’s Representative of the rank of LIEUTENANT OR RANK SUPERIOR TO LIEUTENANT. Petitions will be available **August 8, 2023, through August 28, 2023**, at www.chipabf.org or in the Pension Fund office at **221 N. LaSalle Street, Room 1626**. The Petitions of candidates must be filed **in-person** during the period of **August 29, 2023-September 5, 2023**, both dates inclusive, at the **Pension Fund Office from 9:00 A.M. to 4:00 P.M.** The sufficiency of any Petitions may be challenged in writing from **September 6-7, 2023**. Any candidate may withdraw his or her Petition on or before **September 7, 2023**. The sufficiency of all nominating Petitions shall be ruled on by the Retirement Board as soon as possible after **September 7, 2023**. No Candidate’s name shall be printed on the ballot unless he or she has filed a Petition.
