One (1) member is to be elected from among active members of the CPD of the rank of Investigator, Patrolman or Rank equivalent thereto. The petition for each such candidate must be signed by fifty (50) persons duly qualified to vote for the Policemen's Representative of the rank of Investigator, Patrolman or Rank equivalent thereto. Petitions will be available March 1, 2024 through March 21, 2024, at www.chipabf.org or in the Pension Fund office at 221 N. LaSalle Street, Room 1626. The Petitions of candidates must be filed in-person during the period of March 18 - 22, 2024, both dates inclusive, at the Pension Fund Office from 9:00 A.M. to 4:00 P.M. The sufficiency of any Petitions may be challenged in writing from March 25 and 26, 2024. Any candidate may withdraw his or her Petition on or before March 27, 2024. The sufficiency of all nominating Petitions shall be passed upon by the Retirement Board on March 27, 2024. No Candidate's name shall be printed on the ballot unless he or she has filed a Petition.
