# Officer Tasha Flippin – Duty Disability

This status hearing was conducted pursuant to Article 5 of the Illinois Pension Code concerning the duty disability claim of Officer Tasha Flippin.

Officer Flippin appeared before the Board, with Attorney Ralph Licari as counsel, on her application for a 75% duty disability benefit.

Pursuant to a subpoena, Clinical Manager and a Physician Assistant Sarah Ludwigsen from Concentra, fielded questions and provided testimony regarding the disabling claim of Officer Flippin. Following all testimony and questions from the Board and from Attorney Licari, she was excused from the meeting.

The Board decided to take a brief recess.

Records were reviewed and testimony was taken from claimant.
