DISCUSSION REGARDING CASH FLOW

Executive Director Kevin Reichart presented the Fund's cash flow and cash needs. He reported that the Fund has cash on hand of \$257.3 million. We expect estimated disbursements of \$89.1 million. Payroll is anticipated for \$4.45 million which leaves the Fund with a projected cash on-hand as of August 31, 2025 with \$172.65 million.

Mr. Reichart further noted the Fund is still expecting \$377.8 million in City contributions toward the 2024 tax levy, paid in 2025 representing approximately 59.34% of the totasl 2025 amount owed of \$929 million.

The Fund will continue to monitor cash needs and will submit the 2025 cash advance request should PABF need funds for October.

CONSIDERATION AND POSSIBLE ACTION REGARDING AMENDMENT TO 2025 BUDGET

Executive Director Kevin Reichart addressed the Board. The Fund's website vendor informed the website software platform is not being supported any longer. To continue the website, the vendor must update the software platform incurring additional costs from the Fund. Director Reichart requested the budget be amended to account for these costs, approximately \$8,000 additional will be required for Technology and Support Software as a 2025 expense.

A motion was made to update the 2025 budget as recommended by the Executive Director by \$8,000 to accommodate the costs that will be occurred while the vendor updates the website software platform was made by Trustee Wright, seconded by Trustee Lonergan.
