**Directions -Summarized From RULES OF ELECTION (PETITION)**

One (1) member is to be elected from among Annuitant Members of the PABF. The petition for each such candidate must be signed by twenty-five (25) persons duly qualified to vote for the Trustee representing Annuitant Members. Petitions will be available **December 31, 2025 through 4:30pm on January 9, 2026**, at [www.chipabf.org](http://www.chipabf.org) or in the **PABF Office, 221 N. LaSalle Street, Room 1626**. The petitions of candidates must be filed **in-person** during the period of **January 5, 2026 beginning at 9:00 A.M. through January 9, 2026 at 4:30 P.M.**, at the **PABF Office**. The sufficiency of any petitions may be challenged in writing **January 12-13, 2026**. Any candidate may withdraw his or her petition on or before **January 20, 2026**. The sufficiency of all nominating petitions shall be passed upon by the Retirement Board at a meeting to be held in **January 2026**. No candidate's name shall be printed on the ballot unless he or she has filed a passed upon petition.
