One (1) member is to be elected from among active members of the CPD of the rank of Sergeant. The petition for each such candidate must be signed by twenty-five (25) persons duly qualified to vote for a CPD Officer of the rank of Sergeant. Petitions will be available **August 3, 2026, through August 25, 2026**, at the Pension Fund office at 221 N. LaSalle Street, Room 1626, or at www.chipabf.org. Candidates must file their petitions in person at the Pension Fund office from **9:00 a.m. on August 20, 2026, through 4:00 p.m. on August 26, 2026**. The sufficiency of any candidate's petitions may be challenged, in writing, beginning on **August 27, 2026**, and ending at **4:00 p.m. on August 28, 2026**. Any candidate may withdraw his or her petitions on or before **4:30 p.m. on August 28, 2026**. The Retirement Board shall rule on the sufficiency of all nominating Petitions as soon as possible after **August 28, 2026**.
